exercise such powers and authorities as assigned to you, from time to time and which may be modified/amended by the Chairman, the Board of Directors and the Managing Director and Chief Executive Officer of the Company, provided that in exercising the powers or doing any act or thing, you shall be subject to the provisions of the Companies Act, 2013 or any other Act or the Memorandum and Articles of Association of the Company or any other regulations in force, from time to time, including regulations made by the Company in General Meeting or by the Board of Directors.

4. The remuneration payable to you with effect from 22nd May, 2021, as fixed by the Board of Directors is as under:

A. Consolidated Salary: Rs. 3,50,000/- per month (Rupees Three Lakhs Fifty Thousand Only), (from 22nd May, to 21st. May, 2022),

C. Perquisites:


In-addition to the above, you will be entitled to the following perquisites:

The Appointment and the above salary and perquisites will be subject to the provisions of Sections, 196, 197, 198 and 203, read with Schedule V and other applicable provisions if any, of the Companies Act, 2013 and shall be subject to the approval of the Shareholders by Special resolution at the ensuing Annual General Meeting of the Company.

- You will be required to safeguard all secrets of the Company and shall not divulge any information or data which shall or may be detrimental or adverse to the interest of the Company and shall execute a secrecy agreement in the form hereby annexed.
- 6. During the period of your appointment with us you shall not undertake any private assignments. During the period of your appointment your services can be terminated by either side by giving three months' notice. The Company however reserves the right to offer you three months' salary and perquisites as above, in lieu of notice.
